Povzetek:

Raziskava o odnosu slovenskih in avstrijskih podjetij do podnebnih sprememb in njihovih inovacijskih aktivnostih. Namen raziskave je bil razumeti vpliv podnebnih sprememb na podjetja v gozdno-lesnem sektorju, odnos podjetij do podnebnih sprememb in njihovo motivacijo za delovanje v zvezi s podnebnimi spremembami ter kako podnebne spremembe podjetja spodbujajo k razvoju novih strategij, postopkov ali produktov. Podatkovna datoteka je v angleškem jeziku in zajema tudi podatke o podjetjih iz drugih administrativnih virov: register Bizi.si (SI) in Firmeninfo.at (AT). Podatki se nanašajo na različna časovna obdobja, in sicer na sedanost (čas izvajanja ankete) in preteklost (obdobje 2016-2018 ali obdobje 2018 do 2020).

Kot vzorčni okvir je bil uporabljen register Bizi.si za Slovenijo in Firmeninfo.at za Avstrijo. V vzorec je bila zajeta celotna populacija podjetij v gozdno-lesni vrednostni verigi, katerih dejavnost po NACE kodi je: Gozdarstvo, Lesna industrija, Papirna industrija, Pohištvna industrija, Gradbeništvo, Trgovina in Druga industrijska dejavnost. V primeru Avstrije je bilo obdobje zajetja maj oz. junij 2021, v primeru Slovenije pa januar 2019, za podjetja, ki so bila ustanovljena do konca leta 2018 ter maj 2021 za podjetja ustanovljena v letih 2019 in 2020.

Vprašanja sklopa E so v slovenskem in nemškem vprašalniku prikazana zgolj za obdobje 2016-2018, četudi so bila zastavljena tudi za obdobje 2018-2020. Priporoča se uporaba angleške verzije vprašalnika.

Opis zbiranja podatkov:

Vabilo s povezavo do spletne ankete v orodju LimeSurvey je bilo poslano na 2295 elektronskih naslovov slovenskih in 3048 elektronskih naslovov avstrijskih podjetij v gozdno-lesnem sektorju. Vabila so bila poslana tudi podjetjem, ki so bila povabljeni k sodelovanju tudi v predhodni raziskavi o inovacijskih dejavnostih v letu 2019. V obeh raziskavah je sodelovalo 40 podjetij.

Ukrep za zmanjševanje manjkajočih podatkov:

Podjetjem so bili poslani do 4. opomniki. Slovenskim podjetjem, ki so sodelovala oz. so bila povabljeni k sodelovanju v pretekli raziskavi o inovacijskih dejavnostih (2019) je bilo poslano poročilo omenjene raziskave z namenom motiviranja za sodelovanje v tokratni izvedbi.

Podatki so bili prečiščeni v excelu. Pri odprtih vprašanjih je bilo pregledano, ali so odgovori v okviru predvidenih

rangov. Na podlagi vzorčnega okvira so bili dodani podatki iz administrativnih virov.

Stopnja sodelovanja:

V primeru Slovenije je bilo iz vzorca 2295 podjetij realiziranih 170 anket, kar znaša stopnjo sodelovanja 7,8 %, v primeru Avstrije pa je bilo realiziranih 123 anket iz vzorca 3048 podjetij, kar znaša 4,2 % stopnjo sodelovanja.
